## BREEDING CONTRACT

This agreement is made and entered upon on \_\_\_\_\_, by and between Paso Finos de Zorro Rojo, LLC (PFdeZR), and: \_\_\_\_\_, hereinafter referred to as the "mare owner."

Terms of this agreement are as follows:

1. This contract provides for the breeding:

*\* Note: The mare owner must submit a copy of the mare's PFHA Registration with this Breeding Contract.*

2. COMPENSATION: For the breeding fee of: \$\_\_\_\_\_ USD. One half (50%) payable at the time of this agreement, the remaining (50%), along with all other unpaid charges (as set forth below) shall be paid when the mare is declared "in foal" at thirty (30) days. \$250 of the breeding fee is non-refundable.

3. SHIPPED SEMEN:

The mare owner shall be responsible for all costs involved in collection, shipping, and return on the shipping container as well as any veterinary expense.

4. LIVE COVER:

A. PFdeZR, its agents, and employees, will not be liable or responsible in any manner for any disease, accident or injury to the mare and the mare owner acknowledges that the mare will be on PFdeZR property entirely at the mare owner's risk.

B. The mare owner warrants that the mare is in a healthy condition and has had a current Coggins. A copy of a within 30 day Veterinary Health with negative uterine culture, and one year Coggins Certificates must accompany the mare when delivered to PFdeZR. If this documentation is not provided, PFdeZR reserves the right to reject the mare, or quarantine the mare and obtain the required documentation at the mare owner's expense. Further, the mare owner warrants that all vaccinations and worming are current.

C. The mare owner agrees to be responsible for, and pay for, any veterinary expenses incurred on behalf of the mare. The mare owner gives PFdeZR express permission to call a veterinarian, without first contacting the mare owner, if an emergency situation arises in which PFdeZR feels that time is critical and immediate attention is necessary.

D. Mare care is \$20.00 per day, with foal by side \$25.00 per day.

E. A collection fee of \$100.00 per heat cycle will be charged.

5. REBREEDING:

In the event that the mare does not conceive, aborts, or the foal born does not live for 30 days, including the date of birth, PFdeZR agrees to give the mare owner rebreeding privileges at any time within one year from the date of death of the foal or, if applicable, during the year the mare aborts or the season following the abortion.

B. In the event the mare is unable to rebreed, again aborts, or foal death within 15 days, the mare owner may breed a substitute mare, subject to PFdeZR approval. If approval is not granted, the breeding fee, less \$250.00 administration fee, will be refunded.

C. In the event the stallion is unable (as evidenced by his ill health or death) to rebreed the mare, another stallion with compatible bloodlines may be substituted for rebreeding to the mare with the mare owner's approval. If there is no substitute, the stud fee will be refunded to the mare owner by PFdeZR.

6. In the event that the mare cannot be certified in foal after three successive heat cycles in both the year the contract is signed and the following year, PFdeZR reserves the right to unilaterally withdraw from this agreement and return the breeding fee less \$250.00 administration fee.

7. BREEDER'S CERTIFICATE: PFdeZR agrees to complete the stallion owner portion of a PFHA Registration Application after the mare is declared "in foal" and all monies due PFdeZR are paid. In addition, the annual PFHA Stallion Report will include this breeding.

8. This agreement may not be assigned or transferred by either party hereto without written consent of both parties.

**9. Under the Equine Activity Liability Act (Illinois Statutes Chapter 745. Civil Immunities Act 45), each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.**

*The preceding agreement is understood and accepted. There are no oral terms or conditions outside of this written agreement.*
